by the first supplement dated 3 September 2020 which has received approval number 20-437 from the AMF and the second supplement dated 21 October 2020 which has received approval number 20-522 from the AMF, which together constitute a base prospectus for the purposes of the Prospectus Regulation, save in respect of the Conditions which are the 2018 EMTN Conditions.
